TERMS AND CONDITIONS OF NON – RESIDENTIAL GOLF CLUB MEMBERSHIP

As of the 1st March 2019, it is compulsory for all non-residential individuals desiring to become sports section members to be Simbithi Country Club (CLUB) Members, first.

APPLICATION

Once the application form has been completed, please drop off at the Pro Shop; or e-mail to proshop@simbithi.com. You will receive a confirmation within 48 hours of receipt of full payment. CLUB management and EXCO reserves the right to refuse, cancel, suspend and terminate membership at any time. Should the CLUB management elect to refuse membership to an individual, the pro rata fees by the individual shall be returned to him/her within 21 days. Should the EXCO and the CLUB management elect to admit the individual as a member the individual shall be notified in writing.

Simbithi Country Club membership is granted to an individual and may not be ceded or shared by a spouse, partner or child or any other person. Should the individual's spouse, partner or child wish to become a member of the CLUB, an additional membership form is to be completed and the annual appropriate fee is to be paid.

DURATION OF MEMBERSHIP

Non-residential CLUB membership is valid for a period of one year. Membership shall expire after a year and membership for every subsequent year will be on annual re-application to the CLUB as well as payment of annual fees as determined by the EXCO.

FEES

The annual membership fee for each non-resident member will equate to 1/12th of that paid annually by resident members. In addition to the annual non-resident membership fee, the individual will also be obliged to pay the annual membership subscription for the sport section(s) that he or she intends to join. Fees and subscriptions are to be paid annually and in advance. Notwithstanding the payment of Membership Fees, the right to admission is reserved.

EXCLUSIVE BENEFITS OF MEMBERSHIP

By virtue of their SCC Membership, Golf section members are afforded the added benefit of the option to join Simbithi Gymnasium at an additional cost. Non-residential members have the option of a five percent discount off all food and beverage purchases, should they wish to hold pre-paid credit with the CLUB Accounts Department. This will be determined on application, only.

CONSTITUTION AND RULES

During their tenure Members are, at all times, subservient to the provisions of the Country Club constitution, rules and policies as amended from time to time.

Members shall be deemed to be aware of and to be bound by this Constitution and the RULES OF THE CLUB, as well as all decisions of the EXCO (which bears the responsibility for management of the CLUB) and amendments to the Constitution or RULES OF THE CLUB of which the MEMBERS have been given notice in terms of this Constitution.

Only residential members shall have the right to vote at formal meetings.

CONDUCT

Common courtesy and respect of other members is not only encouraged; it is expected.

Abusive language and aggressive behaviour will NOT be tolerated.

Members and their guests should dress in a manner befitting of our CLUB standing. Members are required to dress appropriately according to the occasion or time of day.

Members are not permitted to remove any items such as towels, books, cutlery, equipment or any other articles from the CLUB premises.

The primary objective of the CLUB Management and Staff is to provide service to the members and their guests. It is imperative that they be treated with utmost courtesy and respect at all times.

Members will be subject to the Disciplinary Code of Conduct.

INDEMNITY

The EXCO, Simbithi Country Club, SECTION COMMITTEES and all officers and staff thereof are hereby indemnified and held harmless out of the funds and property of the CLUB in respect of any and all claims against them personally or collectively arising out of the activities of such, provided that they shall not be indemnified in respect of any actions by them committed or omitted in bad faith recklessly or with the intention of causing damage or loss to the CLUB or its MEMBERS.

MEMBERS agree that they enter upon the SEEHOA and utilize the facilities of the CLUB entirely at their own risk and that Simbithi Eco-Estate (Pty) Ltd, the CLUB and SEEHOA shall not be liable under any circumstances whatsoever for any injury to person or any loss of, or damage to, any property that may occur as a consequence of any MEMBER entering upon the ESTATE and/or using the CLUB'S facilities. MEMBERS waive all claims against Simbithi Eco-Estate (Pty) Ltd, the CLUB and SEEHOA for any loss of or damage to property or injury to person which any may sustain in or about the ESTATE, including the CLUB, and indemnify Simbithi Eco-Estate (Pty) Ltd, the CLUB and SEEHOA against any such claim that may be made against Simbithi Eco-Estate (Pty) Ltd, the CLUB and SEEHOA by members of their family, their invitees or any other person who may go upon the ESTATE, including the CLUB, by virtue of their rights thereto, for any loss or damage to property or injury to person suffered in or about the ESTATE and the CLUB however such loss or damage to property to injury to person may be caused. If the CPA applies for the benefit of a MEMBER or any person who goes upon the ESTATE and the CLUB by virtue of the MEMBER'S rights, the exclusion of liability and indemnity in this clause will not apply to any loss directly or indirectly attributable to the gross negligence of Simbithi Eco-Estate (Pty) Ltd, the CLUB or SEEHOA or any person acting for or controlled by any of them.

CONSENT IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT, 2013 ("POPI")

I acknowledge that Simbithi Country Club, their governing bodies and management from time to time (collectively, "Users") will collect my personal information and that of my family including but not limited to name(s), identity number(s) or passport number(s), birth date(s), age(s), photograph(s), email address(es), physical address(es), postal address(es), telephone number(s), geographic location(s), , vehicle registration number(s), vehicle license(s), drivers license(s), correspondence which is private or confidential, biometric information (including, if applicable fingerprints and/or retinal scanning), billing information and bank statements, the other categories of personal information included in the definition of "personal Information" in POPI and such other information as is reasonably required by us to engage with you and/or provide services to you or otherwise voluntarily disclosed by you to us (Personal Information).
